


COMPARISON OF 2025 QUARTER II AND 2024 QUARTER II






NUMBER OF CONTRACTS:










Graph 1- Number of Employee and Profitability Per Employee






Over the past five years, fluctuations have been observed in the number of employees and in the profitability per employee.

Graph 2- Number of Employee and New Business Volume Per Employee






Fluctuations in the number of employees and in new business volume per employee have been observed since the second quarter of 2020.
