

### **COMPARISON OF 2023 QUARTER III AND 2022 QUARTER III**

#### **NEW BUSINESS VOLUME:**

• 2023 Quarter III new business volume is 1.146.115 thousand USD, which is a **51%** increase compared to 2022 Quarter III of 760.720 thousand USD. If we evaluate the increase in new business volume in TRY, the growth is **122%**.




• 2023 nine-months cumulative new business volume is 3.742.057 thousand USD, an increase of **36%** compared to the same period of 2022, which was 2.743.291 thousand USD. If we evaluate the increase in new business volume in TRY, the growth is **89%**.




#### **NUMBER OF CONTRACTS:**












**Graph 1- Number of Employee and Profitability Per Employee** 






While the number of employees has been decreasing over the past 4 years, profitability ratio per employee has been changing over time.


Graph 2- Number of Employee and New Business Volume Per Employee






While the number of employees in the sector has been decreasing since 2018 Quarter II, new business volume per employee ratios have been on upward trend since 2019 Quarter II.
