


COMPARISON OF 2024 QUARTER III AND 2023 QUARTER III






NUMBER OF CONTRACTS:










Graph 1- Number of Employee and Profitability Per Employee






The number of employees and profitability ratios per employee have been on an upward trend over the past 5 years.

Graph 2- Number of Employee and New Business Volume Per Employee






While the number of employees in the sector has been changing over time since 2019 Quarter III, new business volume per employee ratios have been on an upward trend since 2022 Quarter III.
