World Factoring Turnover (Million USD)

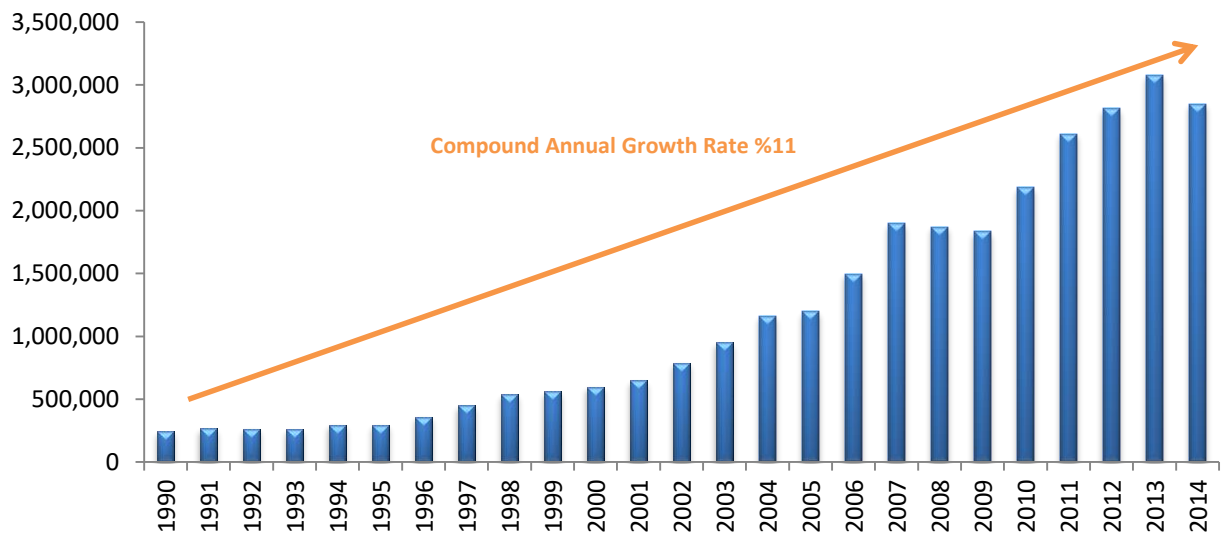

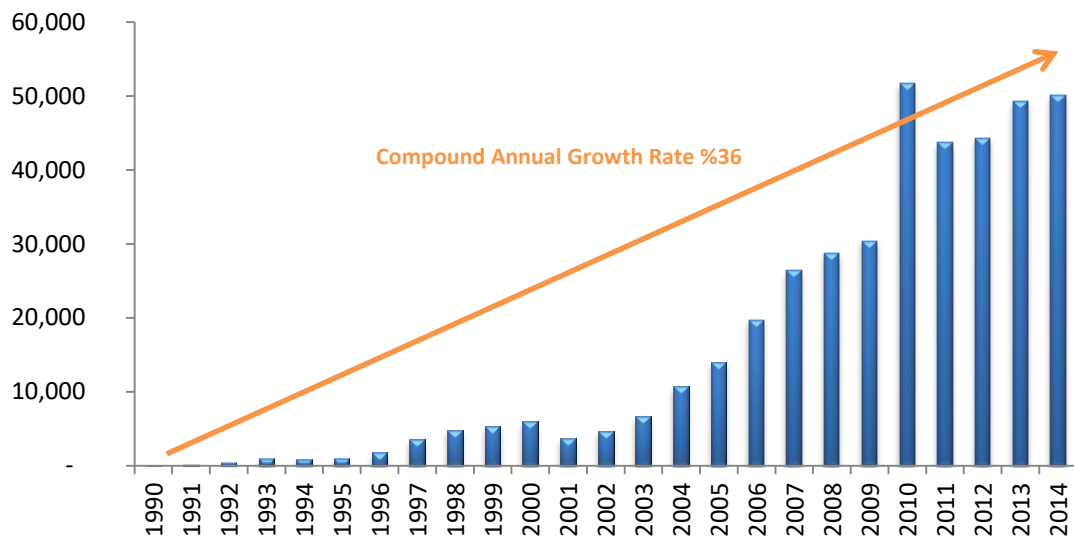
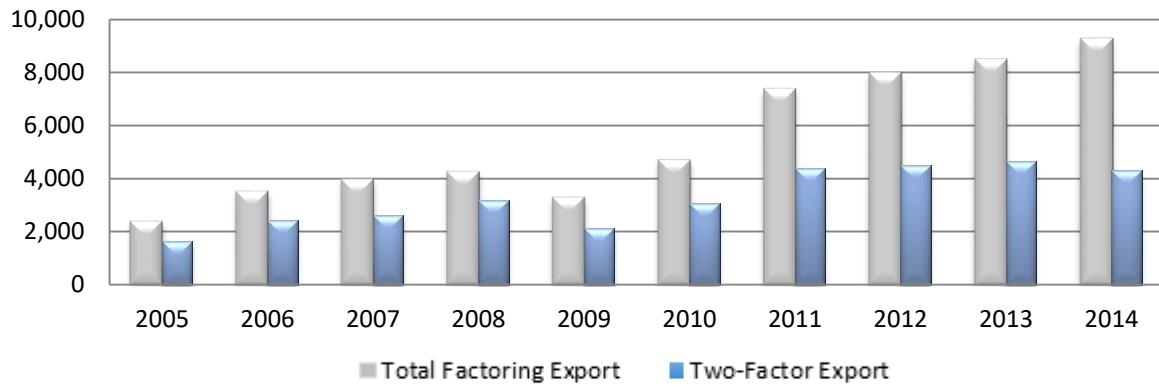
